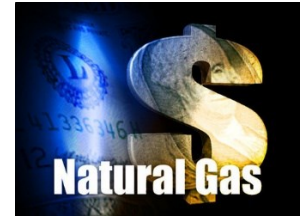

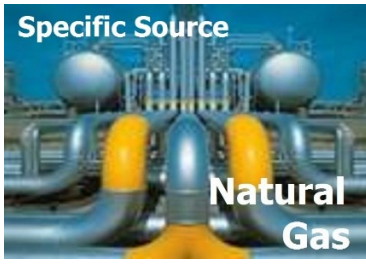
CNG Compressor Unit Installation

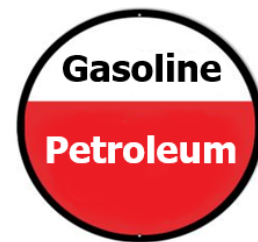
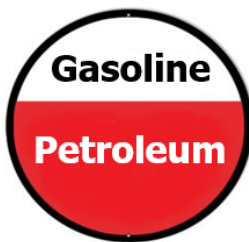
Natural Gas Pressure Regulator Station for 12", 10", 8" inch Pipelines

Obsolete Gas / Petrol Filling Stations Closed Down or Need to be Torn Down
